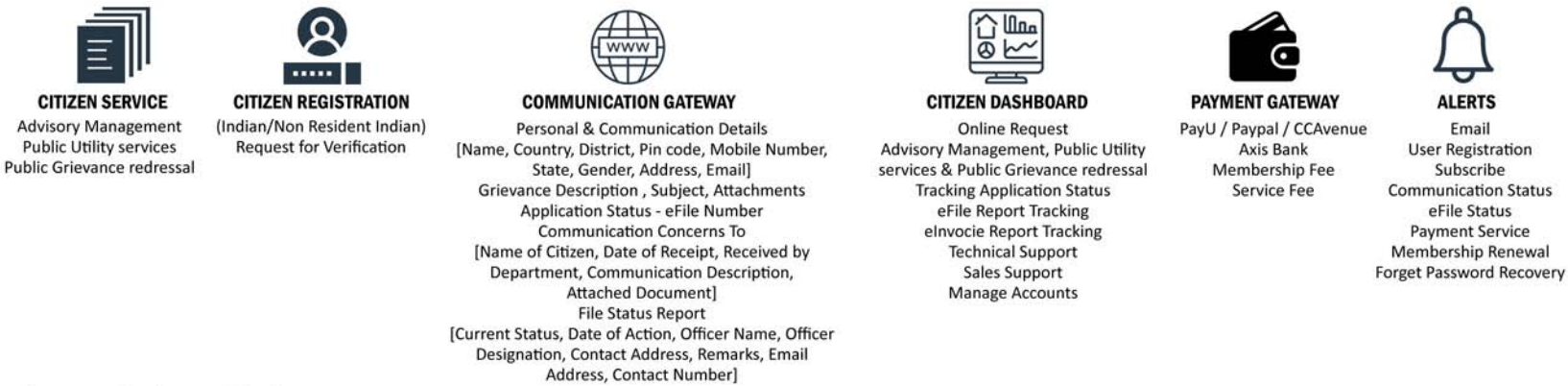
Platform

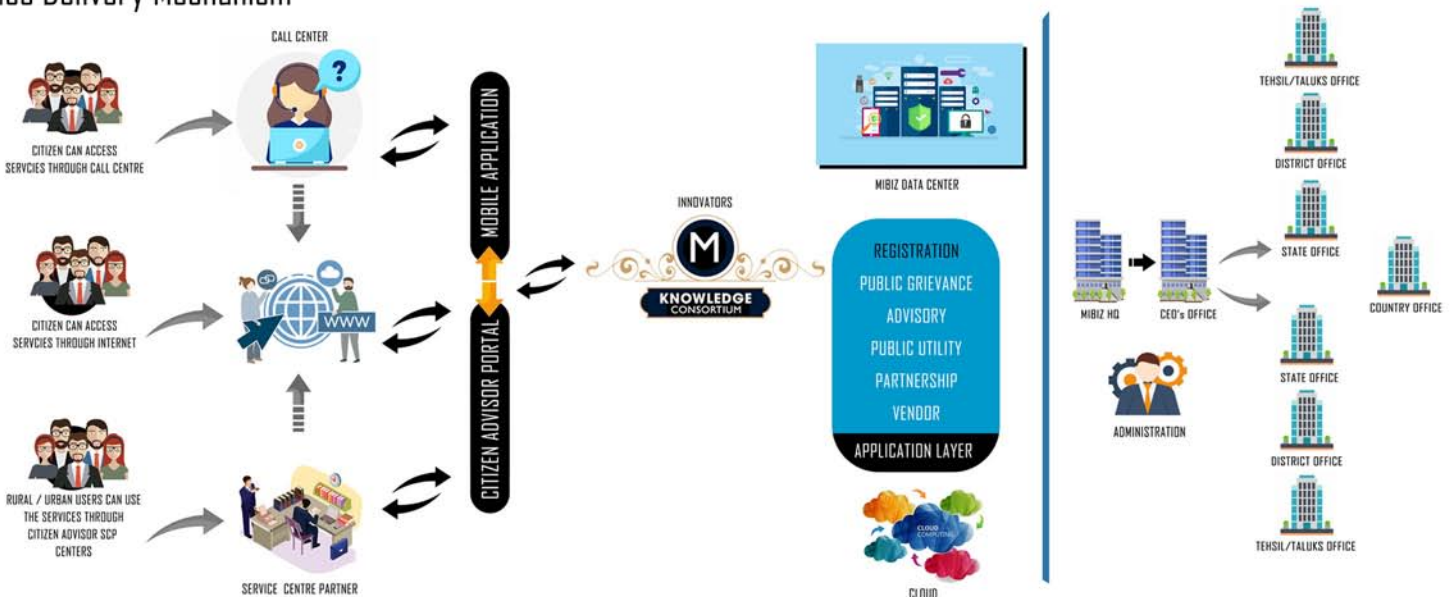

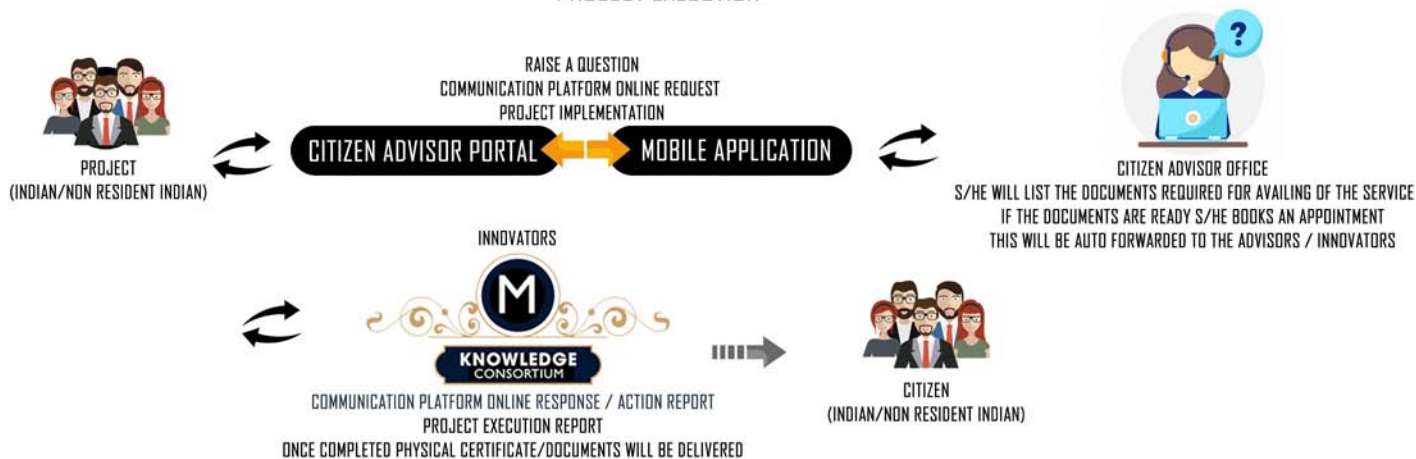
